THEATRICAL PRODUCTIONS: MILWAUKEE REPERTORY THEATER PRODUCED 11 PLAYS IN ITS 2019/2020 SEASON. THESE PLAYS WERE PRODUCED ON OUR OWN 3 STAGES AND AT THE HISTORIC PABST THEATER. WE PRESENTED 613 PERFORMANCES TO AN AUDIENCE OF 163,073 PEOPLE. TICKETS ARE PRICED AT A SUBSTANTIALLY SUBSIDIZED RATE AND MANY ARE FULLY UNDERWRITTEN IN ORDER TO PROVIDE FULL ACCESS.

NEW PLAY DEVELOPMENT: IN THE 2019/20 SEASON THE REP WAS SCHEDULED TO PREMIERE HOOTENANY AND ANTONIO'S SONG BUT BOTH PRODUCTIONS FELL VICTIM TO THE COVID-19 PANDEMIC.
